Keith Seibel: got together leaders from each of his districts to discuss issues each is facing, all 5 councilmembers from Verona were in attendance; hosting the next Town Hall Community Forum on 2/27 at 6pm at "The Spot"

Scott: We need to start working on the Air B&B law/code, this was one of the topics that was discussed at Keith's meeting with local leaders

Norm Leech: Sand Pipers are taking over the triangle by the airport, so there are plans to try and move them on.

D. Public Concerns

RC: When is the website going to be back up?

TB: The website is up – go to townverona.org the url has been updated

TB: NYS requiring the website for municipalities to be .gov – the process will take a , and we are looking at making that move – also looking at changing to outlook for email use as well.

RC: Parking on the side of the road near the Durhamville VFW – there use to be signs up No parking along the side of the road, signs are gone, and people are parking it the road. blocks through traffic, including fire trucks from accessing that area of town

TB: Be sure to email the information to Scott, he can follow up on that

RC: Just wondering if you have figured out that it's ok for the Codes guy to wander into people's yards?

TB: IF there is a noted violation, yes, the Codes officer has permission to his job. We also spoke with the property owner and was given permission to access the property.

RC: Resident Concern/Comment TB: Town Board

RC: It is illegal for the land owner to give permission, I rent the property. Even the landowner cannot access the property without given legal notice ahead of time, so who do you think you are to be able to access the property. He supposed said I was burning garbage, I was not, it was the Indians across the street. He wondered around my house and scared the crap out of my kids, it is illegal to go on my property, I have already talked law enforcement, he has no right. Not to mention have you figured out if a chicken is a farm animal?

TB: chicken is poultry and considered a farm animal, the definition is listed in the Codes.

RC: I looked in the codes, it's not in there, and my neighbor had chickens for a year, you guys are selectively picking who can and cannot have chickens. The codes say nothing about chic kens, I know I'm not going to get a ticket, so for him to come into my yard and scare my kids, with no cause, an officer of the law needs a warrant, even the DEC need a warrant, and if it was a burning garbage complaint, he should have contacted the DEC, that's a misdemeanor, it was illegal for him to come on my property. He scared the SHIT out of my kids, he does not belong on my property, he can get a warrant if he wants to come in my year. Get a warrant.

TB: Sir, please watch your language. I disagree with your statements.

RC: I don't care that you disagree.

TB: Sir, you have said your peace, now we'd like to move on.

RC: Where's your codes officer?

TB: He is on PTO.

RC: At a training, something was mentioned about the state forcing electric plow trucks on townships? TB: This directive has stalled due to the cost to municipalities. There would need to be a major power grid issue, for that to go into place. Electric trucks are about 3 times the current price, and a current truck is over \$240,000.
