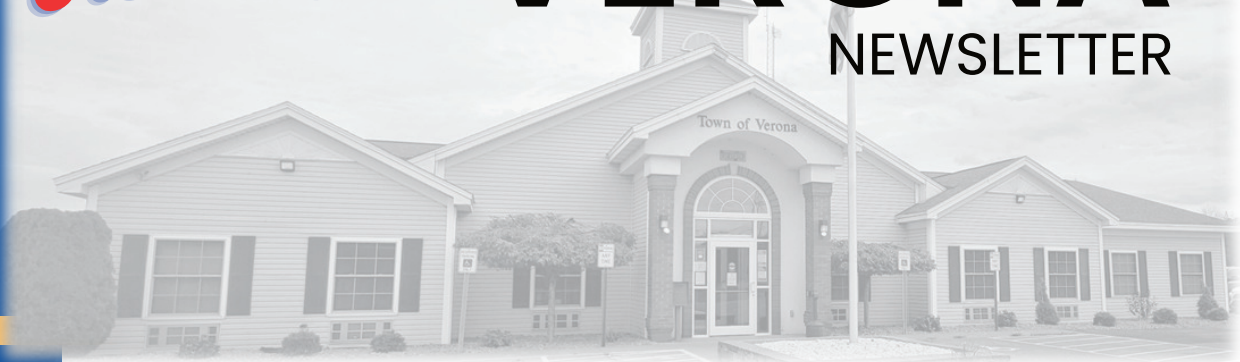

From Agriculture and Markets on Man's Best Friend...

Reminder, all Dogs in the Town MUST be licensed. This is a safety issue for not only visitors but also the dogs, in addition to being a State law.

We have seen an increase in stray dogs the second half of this year. All the local shelters are full, meaning our Dog Control Officer (DCO) must board the dogs. She contacts our shelter (Rome Humane Society) every Tuesday to inquire on space. This is not an issue only in Verona, many of the local DCO's are also having to board stray dogs. Dogs that stay at the DCO shelter are charged to the Town at \$15 a day for food and care. After five (5) days at a DCO shelter, we can legally adopt them out. And for those that follow our FB page, you see the Adoption Alerts and a few success stories.

Licensing your dog is very simple. Proof of vaccination, proof of spay or neuter (if applies) and the licensing fee. You can drop off the information at the Town office, or come in during normal business hours. We will then send you a reminder annually that their license is due to renew.

Spayed and Neutered Dogs = \$10 Intact Dogs = \$18

Movement on the Water Project

CSX Crossing on Rock Road:

This crossing will connect the main transmission water line through New London to existing water infrastructure in Verona. Nine test pits were completed to understand the subsurface conditions adjacent to the tracks. Barton & Loguidice (B&L) and the Town of Verona worked with CSX to determine the safest most cost-effective way to move forward. This was completed early in November and final steps are being taken to complete the connection to the existing infrastructure!!

Barge Canal Crossing:

The photos shared a few months ago, on Facebook and the website, showed the drilling operation under the Barge Canal. Unfortunately, the large boulders (small SUV sized rocks) along the edge of the Canal halted the drilling operation. After many attempts, the drill was unable to get through. The Board is now awaiting information on the 2nd option, a Pipe Bridge over the canal. B&L has started the design process of the pipe bridge crossing. This will be a separate structure from the existing bridge on Rt. 46, for many reasons, one of them being the State is replacing that bridge within a few years.

New London Water Tank:

The water storage tank construction is complete; next step is leak testing. Preload LLC (Tank Contractor) will be able to conduct testing once the Rock Rd CSX crossing is complete.

New London Pump Station:

This project will be the smallest of the four total projects to bring water to Verona. This structure will be built next to the water storage tank in New London and will be fundamental in supplying water from Rome to Town residents within the new and existing water districts. The bid process for this build will be out in early 2024, as we believe the build should only take a couple of months.

Water Service hook-up for residents, the GOOD STUFF:

This is one of the last steps in this process. Each resident receiving a new water hook up will be contacted by either B&L (Town Engineer) or MCI (contractor) to determine where the line should be placed on the property. Each resident will receive a blue stake from B&L and it should be placed at the property line where the water service connection is desired to be located. Construction crews will then install a “meter pit”, at the blue stake location, in front of each house. This meter pit will contain a water meter that will be used to track water usage. From the meter pit the water service piping will be installed to come within 10’ of the home foundation and connect to the existing well piping.

Remember, those that are within the district that choose to hook up now, during the initial installation, will be charged nothing (up to within 10 feet of your foundation), while anyone that waives hook up at this time and years down the road choose to hook up, will be responsible for the cost of installation from road to house.

Movement on the Water Project

Water Billing:

Those new to city water, you will be billed quarterly for usage. So, what you use, you will pay for. Annually, the debt service will be placed on your property tax bill. New residents receiving water will be one set fee; existing residents with water, will be a smaller set fee. Total expense per residence receiving water, which will be the debt service fee and quarterly usage fees have a maximum amount set by the NYS Comptroller at \$1,040.00 annually. Usage billing will not start until water is hooked up and being used at your residence. The debt service fee will be part of the 2025 Property Tax bill, which is sent out in January of 2025.

Restoration:

All property will be restored to its pre-disturbed state. Most property that has been disturbed for the initial install of the permanent water main, has been completed. If you have any additional restoration that is needed, please contact the Town office and we will get you in touch with our engineer and schedule the fix. Once individual resident water lines are installed, a restoration team will follow along within a few weeks. Again, if you have any problems or need to speak with the engineer, please reach out to the Town Clerk; she will pass along the needed information, including how to get in touch with the homeowner.

Reminder:

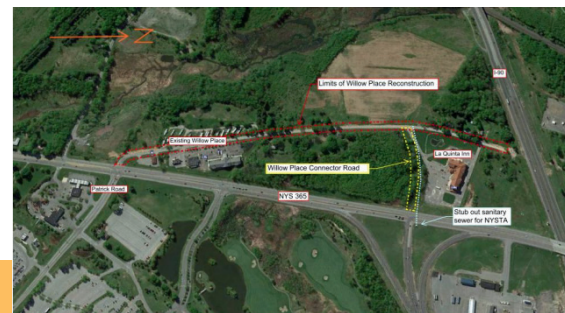
- **You CAN** keep your well water for watering the garden/lawn, or animals.
- **YOU CAN NOT** have both well water and city water within the same plumbing fixtures. There must be complete separation of well water and city water by mandate of NYS Health Department.

We are incredibly thankful to our residents for their patience and understanding during this project. We understand that there have been some inconvenient moments, but glad everyone understands that every project can cause growing pains, but in the end those that have been inconvenienced will have potable, healthy water (and great water pressure)!!

Willow Place Connector Rd.

The Willow Place Connector Road Project, started back in 1995 as the Route 365 Corridor Study/Entertainment & Tourism Zone Development Plan. The basics of the plan are still the same; to enhance the quality of anticipated future commercial development within a proposed “zone” by protecting residential and agricultural areas located outside of the “zone”.

The Town has engaged with outside developers that are very interested in building along Willow Place, however, without a connector road from RT 365 (across from the Thruway) the traffic pattern is currently too dangerous to add additional traffic. Development of the Willow Place Connector Road will increase business in this area, by giving residents additional options for possible restaurants, family activities, and or shopping destinations. The increase of non-Oneida Indian Nation owned businesses will only increase the Town of Verona business district creating additional revenue through building permits, sales tax, and foot traffic.



An Assessors' Note

As Assessor, I estimate the value of real property within the Town boundaries. The value is converted into an assessment. My role is to produce a fair assessment roll, I do not set tax rates or collect taxes. I perform many other administrative functions, such as inspecting new construction and looking for improvements that have been made. This ensures that the record of each property's physical inventory is current and that appropriate improvements are assessed. You may see us out and about taking photographs of new construction and/or sales.

In my office, my clerk and I approve and keep track of property tax exemptions. Among the most common are: the senior citizens, School Tax Relief (STAR), Veterans, agricultural and business exemptions. If you have any questions on exemptions, please feel free to give us a call and we can assist you. The deadline to apply each year for exemptions is March 1. New this year, is the sliding scale used for the senior citizen and limited income disability exemptions. Many residents who were previously ineligible may now be eligible. If you are 65 or older, or are disabled, we can review your income for eligibility.

My office reviews every transfer of real property. Assessment records are updated and any unusual conditions affecting the transfer are also verified. Please keep me informed of any address changes. Upon transfer to new owners, my office sends out a Welcome Pack with local information.

If you feel that your assessment is incorrect, please let me know. I can explain how your assessment was determined and what our records show for improvements on your property. If you still feel that your assessment is incorrect, grievance day is the fourth Tuesday in May. Only your assessment may be grieved, not the amount of your taxes. The Board of Assessment Review meets from 9:00 am-12:00 noon and from 6:00 pm-8:00 pm.

On the Road Again....

The Highway crew stayed busy this year. Two crew members had the privilege to retire this past Spring, their knowledge and support will be missed. We were lucky enough to find two great, local candidates, and look forward to working with them.

This year, the Town paved 5.22 miles of road and oil and stoned 7.43 miles. The year after a road is paved it is also oil and stoned, this, in a way, preserves the pavement and helps protect against weather, and wear and tear. 6.14 miles of road shoulder was completed, along all the newly paved roads and a few that were not completed a few years back. Road culverts on Carpenter Rd., Oatman Rd., Zingerline Rd. and Heelpath Rd. were replaced prior to paving along with pot holes that were addressed and filled, across the town. Town trucks moved 10,000 tons of stone for various projects including culverts, road maintenance and ditching, along with all of the sand for the winter months.

Updated drainage was installed on Canal Street in New London and a long-time drainage issue near Spring Street and Main Street in Verona was re-engineered and completed by our Highway guys and Oneida County. Twenty-five (25) trees were removed from right-of-ways that were dead, dying, or too close to homes and could be dangerous during wind or snow storms.

All of this was done, while still maintaining, mowing, and trimming the town parks, ball fields, cemetery's (that are Town maintained), and water and sewer facilities. Along with working on ditch cleaning, our guys run Spring Clean up when the snow melts, this includes leveling the lawn at corners and resident lawns that were damaged during the winter but also picking up road side trash that is uncovered by the snow melt. This is by far one of the worst jobs, the things that people discard on the roadside are not generally clean, and most definitely need to be done in a safe and cautious manner.

With Spring, comes all the green waste that is dumped at the town site, this is then hauled to the green waste dump off of Yager Rd. weekly. This time of year also lends itself to washing the plow trucks and properly storing the plows until next year.

On top of that, we have a handful of employees that are double trained to help in the instance of a water or sewer break. There were a few instances in the Verona Beach area this year and one in Durhamville that our Highway guys worked, along side the Water Department, to correct as soon as possible.

As we roll into the colder months, the Highway employees will move to a split shift schedule. This ensures coverage around the clock for when those snow storms move in. The split schedule also allows for a comfortable work-life balance for our truck drivers, giving each shift a weekend to cover in case of snow fall and a weekend to plan with family and friends, while still maintaining road safety coverage for the Verona Town residents.

As we roll into a new term for the Highway Superintendent, I'd like to say thank you to all of the residents in the Town of Verona. I enjoy working with you to make our town run as smoothly as possible. I encourage you to call or email me with questions or comments and always reach out if there is an issue or problem. Thank you!

Hello from the Water Department. Looking back on 2023, we spent a majority of the year upgrading the water meters for over 800 current water customers. Water meters in some cases are located inside a basement or back room. As you can imagine, that took a bit to coordinate with home owners, and we'd like to thank everyone involved in getting this project done.

We have also been working with the Town engineer, Barton & Loguidice, and the contractor, MCI, on the water upgrade and extension project, in addition to the day to day Operation and Maintenance (O&M) for the Town's water and sewer infrastructure.

A few water and sewer breaks happened this past summer that we were able to fix with minimal interruption to residents, thanks to help received from a few of the Highway staff.

Next year, we will be working on upgrades to our sewer pump stations and will continue to work closely with our engineers and contractors to complete the water project.

Good News for Water & Sewer Customers!

In 2024, we will be offering an online view and payment option for water payments. This will allow all residents having water and/or sewer to track their usage from billing cycle to billing cycle, make payments online, and optional email billing. More information will be out on these options just after the first of the year.

Durhamville Sewer Project

Barton & Loguidice, D.P.C. has been assisting the Town with developing a project to bring public sewer service to the Hamlet of Durhamville. To date, the following has been completed:

- an income survey was completed, and found to be within the limits for 0% interest hardship loans,
- various NYS infrastructure grants have been submitted and there are additional grants with upcoming deadlines that will also be submitted to help cover a portion of this large project.

Happenings at the Historical Building

2023 has been a busy year at the Historical Building as we continue to promote Verona’s history and offer many programs and events to the public. 2023 started out with the opening of a new exhibit entitled, “Blowers, Flatteners & Cutters: Glass Manufacturing in the Town of Verona.” The exhibit features both the Durhamville and Dunbarton Glass Works. Interpretive panels with photos and text allows the public to learn about this important 19th century industry. Although these factories primarily produced window pane glass, the exhibit also features a display case showing off many glass items made by workers from the leftover molten glass at the end of the day.

In March, the Verona Historical Association hosted the inaugural Family Day Train Show. For the event, train exhibitors set up and operated their personal train collections to the delight of train enthusiasts young and old. The 2nd Annual Antique Car Show was held in July along with hosting the Model A Car Club. Other organizations we hosted this year and provided programs for include the Daughters of the American Revolution; Our Lady of Good Council Alter Rosary Society; and Cub Scouts Pack 25. Lectures throughout the year included Verona Glass Factories in conjunction with the exhibit opening; Oak Orchard Cemetery in conjunction with the installation of a new sign on Wood Creek Road; History of Verona Springs; Abolitionism and the Underground Railroad in Central New York; and My Darling Jane: Letters Home from World War II.

Now that people realize the Historical Building is open on Wednesday from 9 am – 4 pm and thanks to a new sign we put out by the road announcing we’re open, many people have stopped in to view the museum and use our extensive research facilities. In the museum we completed upgrading our general store exhibit and are currently working on upgrading our one room school house exhibit. We also built a collections storage area with shelves to store objects while we upgrade areas of the museum. Our final activity for 2023 will be held on December 9th with our annual Christmas party and pot luck luncheon where we all gather to celebrate the Christmas season, enjoy good food, and reflect on the past year and plan for the upcoming year.

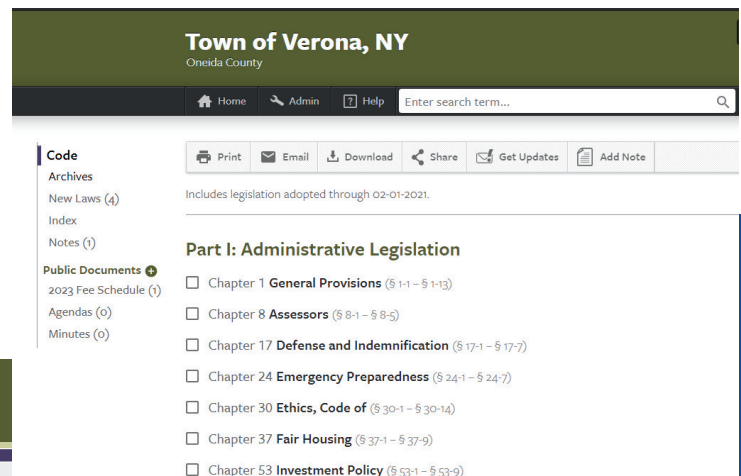
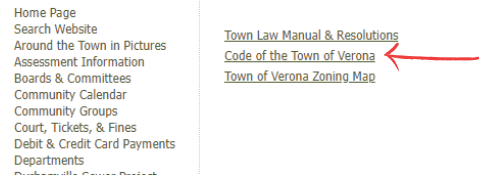
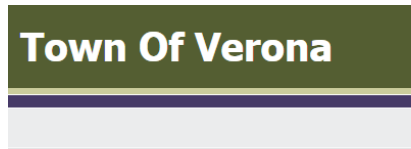
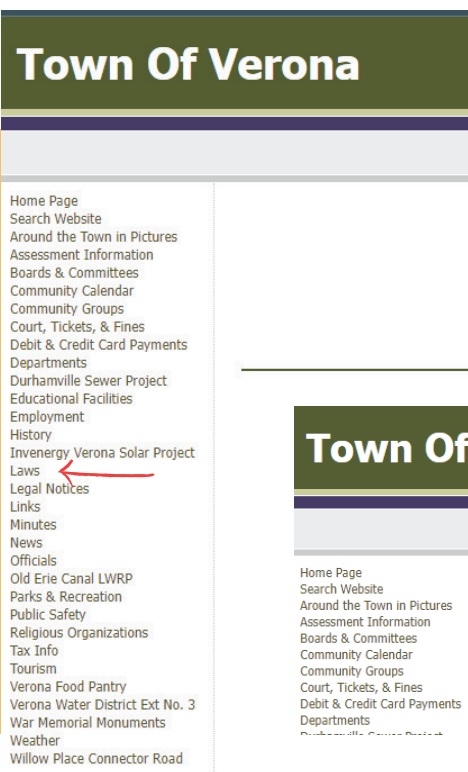
Updated Codes and Local Laws

2023 was the first full year for our new Codes Enforcement Officer, Dan Maciag. Dan successfully completed the New York State required training to become a certified Codes Officer in September. That process is not easy, it is all online based, six (6) separate courses over 5 months. Each course is 4 days, 8 hours per day online with an instructor followed by a test the following Wednesday. Five (5) of the courses contained content from over 400 pages of building code, fire code, structure code, capacity code and more. A big congratulations goes out to Dan for his success, we wish him a successful future with our Codes department.

A reminder to all residents, the Town of Verona has a refuse code, meaning you are not allowed to keep junk cars, garbage, and multiple appliances, among other items in your yard. You risk being in violation and receiving a citation.

Resolutions passed in 2023 varied from Lead Agent for the Durhamville Sewer Project to creating the official Durhamville Sewer District, various resolutions regarding the ATV Trail system in Verona - culminating in the passing of Local Law 1 of 2023 "A Local Law permitting and regulating all-terrain vehicle operations on certain public roads in the Town of Verona, New York. Did you know, information from the Town of Verona. ..

Did you know, **Town and County Taxes** will go out January 1, 2024? Every land owner in the Town of Verona will receive their tax bill just after the 1st of the year. This bill reflects the County Tax, Verona Highway Tax, and any special district taxes, i.e. Fire Departments, sewer, water .

You can pay and view your bill online at the Town of Verona website, using the blue box (link) in the middle of the page marked "Property Tax". All major credit cards and e-checks are accepted. Parcel Tax information remains there, year round. If you choose to pay in-person (with exact change), the online platform will update with your payment within 24 hours, meaning you could print out a paid receipt from home the next day if you lose your original.

Did you know the **Verona Food Pantry** serves about 100 Town of Verona families a month. They are open on Tuesdays from 1pm - 2:30pm and Thursdays 5:30pm - 7pm. Food Pantry elves are all volunteers! A HUGE shout out to our Food Pantry Volunteers, without you our Town would be much hungrier!! Thank you.

Did you know that the **Town rents out the Park Pavilion and the Historical Building**? Under “Parks and Recreation” on the Town website, you can reserve either the beautiful outdoor pavilion or the large meeting space in the front of the Historical Building. We require a refundable \$100 deposit for the pavilion; once the space has been cleared by staff as “clean” you will be contacted to pick up your check or cash. For the Historical Building, a \$100 deposit (\$50 rental fee is requested and a \$50 refundable deposit), due to the facility having a kitchen. Again, once the space is deemed “clean” the refundable portion will be returned to the renter.
